

Goal 1 - To implement a more robust and responsive Assessment framework for identification of schools and effective resource allocation

- Applied on same basis across primary and post primary.
- CSO Small Area data, as represented by Haase Pratschke Deprivation Index, combined with geo-coded POD and PPOD data.
- Based on socio-economic profile of pupil cohort in each individual school (not location of school).
- Robust and responsive.
- Ultimate aim is to match resources to identified need.





Goal 2 - To improve the learning experience and outcomes of pupils in **DEIS** schools

Supports to DEIS schools:

- financial
- literacy and numeracy support
- lower class size in Urban Primary Band 1
- allocation of Administrative Principal on lower threshold
- enhanced guidance allocation
- access to School Meals Programme

Goal 3 - To improve the capacity of schools leaders and teachers to engage, plan and deploy resources to their best advantage

- Focus on teachers as leaders of teaching and learning.
- Supporting initial teacher education.






National Traveller and Roma Inclusion Strategy 2017-2021








NTRIS – Traveller Pilot Project


Traveller Pilot Project is led by Tusla, targeting the three main criteria below






Migrant Integration Strategy


- Published by the Department of Justice and Equality 2017.

- Fifteen actions under this theme fall under the responsibility of the Department of Education and Skills, the Education and Training Boards (ETBs), SOLAS and other Training Providers.
- Education actions mainly relate to the provision of language supports for children and adults whose first language is not English.
